## LET SPORT LAW HELP WITH ONCA REQUIREMENTS

## **Background? New Not-for-Profit Act**

The Corporations Act, originally enacted in 1907 was long overdue for an update. That update occurred in 2010 when the new Ontario Not-for-Profit Corporations Act (ONCA) received Royal Assent.

Although the Act received Royal Assent in 2010, it only came into force, October 19, 2021. At that time existing not-for-profit corporations had 3 years to update their articles and amend their bylaws.

With the deadline drawing near, it is recommended that all not-for-profit corporations, previously governed under the Corporations Act, review and update their documents, (by-laws and Articles of Incorporation), **prior to Oct 19, 2024.** 

## **Ontario Business Registry**

The Ontario Business Registry (OBR) was also launched on October 19, 2021.

The OBR enables not-for-profit corporations (together with for-profit corporations) that are registered, incorporated or licensed to do business in Ontario to complete over 90 transactions online:

- Registering a new business
- Dissolving
- Annual Filings
- Notice of Change Directors
- Articles of Amendment

You are required to register and ascertain a corporate key and login from the OBR to access records.

## Changes introduced under ONCA

- Membership structures must be outlined in the corporation's articles
- Members can put forward proposals at annual general meetings and special meetings
- Allows a not-for-profit corporation to provide in its by-laws other means of voting (by mail, telephone or electronic means) in addition to, or in place of, voting by proxies
- Allows a member of a corporation to appoint a proxy holder, but only if the articles or the by-laws of the corporation permit it
- New eligibility criteria for directors
- Minimum number of directors and maximum terms for directors
- Distinction between public benefit corporations and other not-for-profit corporations
- Greater accountability for financial reporting
